Proof of Eligibility: Make-A-Splash is a program offering swim lessons free of charge or half-off as a service to those who would otherwise not be able to attend. In order to qualify for this swim program, USA Swimming requires that applicants must be approved by the public school system to receive free/reduced-price lunches or meet those criteria. **A copy of the school's letter provided to families who qualify must be included with this application.**

The Baylor Swim Club donates a total of two scholarships per session, and are on a first come first serve basis. A waiting list will be created if the class you choose is full. See the Policies and Release on page two for more information.

Baylor Swimming Lesson Policies and Release

Please read and sign the following. Please initial each paragraph

____ **MAKE-UP POLICY: WE DO NOT OFFER MAKE-UPS for illness or conflicts with other activities.**

____ **CANCELLATION POLICY:** To cancel a class you must withdraw at least **TEN DAYS** prior to the beginning of the class. If you withdraw from class, you will *not* receive a refund. **You will receive a credit for the amount you paid for the class less a 15% cancellation fee. No credit will be issued if you withdraw from the class less than Ten Days prior to the beginning of the class**

____ **SCHEDULE CHANGE POLICY:** Schedule changes are subject to class/session availability. All changes must be made at least **TEN DAYS** prior to scheduled session. **All changes are subject to a \$10.00 administrative fee.** Please choose classes carefully.

____ **ILLNESS POLICY:** If your child is absent from class due to illness for **THREE CONSECUTIVE CLASSES** a credit will be issued when a note from his doctor is presented. **No credit will be issued without a note from the doctor.** The note must have the dates that the child was not allowed to be in class. The credit will be \$9.00 per class.

____ **CREDIT POLICY:** Credits will be issued for extended illness (see illness policy above) and pool closures only. Credits will not be issued for conflicts with other activities or vacations.

____ **CREDITS:** *Baylor Swim Lesson* credits may be applied toward future swim lessons, group or private. *Baylor Swim Lesson* credits may not be applied towards swim team dues or entry fund, unless that child is moving from lessons to swim team. . Credits will not be replaced if lost or stolen. Credits are not transferable. **Credits are NOT redeemable for cash**

____ **POOL CLOSINGS: The teaching pool will be closed for the following reasons:**

When a child vomits or has a bowel movement in the pool, the pool must be closed for sanitation.

Inclement weather - If Baylor School is closed due to bad weather there will not be any swimming lessons. If Baylor closes early during the school day due to bad weather all swimming lessons will be canceled for that day. If conditions in the pool make it unsafe for students to be in the pool, the pool will be closed.

BAYLOR SCHOOL NATATORIUM: A make-up class will be scheduled.

____ **SEATING FOR PARENTS AND SIBLINGS:** Parents and siblings of swim lesson students that wish to stay in the building during lessons **must sit in the stands up above the pool or remain in the pool lobby. Parents will be allowed in the teaching pool room during the first 5 minutes and last 5 minutes of the lesson**

RELEASE AND INDEMNIFICATION: For and in consideration of the benefits to me from the use by me and/or my child(ren) of the facilities of Baylor School Natatorium and other good and valuable consideration, the undersigned, individually and of his/her heirs and personal representatives, hereby release Baylor School and Baylor Swim Club's directors, officers, agents, swim team members and employees from any and all claims of any kind or nature whatsoever, arising out of the use by me and/or my child(ren) of said facilities.
