Ensworth Aquatics Holiday Classic December 6 to 8, 2019

This meet will be conducted under the auspices of Southeastern Swimming, Inc. of USA Swimming. USA Swimming technical rules and regulations will be followed with the exception of items specifically addressed in the meet information sanctioned by Southeastern Swimming, Inc.

HOST CLUB: Ensworth Aquatics

LOCATION:

The Ensworth School (Frist Campus) 7401 Highway 100 Nashville, TN 37221

FACILITY:

The Ensworth School offers a 10-lane, 25-yard competition pool, with a 6.5 foot minimum depth, non-turbulent lane lines, a fully automatic electronic timing system, and a scoreboard with lane/time/place display. The competition course has been certified in accordance with 104.2.2C (4). The copy of such certification is on file with USA Swimming.

RULES & NOTES:

- Unless otherwise noted herein, this meet shall be conducted in accordance with current USA Swimming Rules and Regulations.
- Please note that use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.
- Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.



- Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present.
- In the interest of safety and accident prevention, coaches, officials and swimmers are asked to observe all posted pool rules and to conduct themselves in a safe manner. Only coaches, swimmers, officials, and volunteers are allowed on deck.
- Chairs are permitted on the balcony overlooking the pool, but must be placed against the back wall, **not against the railing.**
- There will be a five minute break before all distance events. Meet director/Meet referee have the option to run distance events in two courses. A decision will be communicated on the Wednesday or before the start of the meet.
- Friday afternoon events will be swum as timed finals, fastest to slowest, alternating male and female heats, by event.
- Coaches must show either current USA Swimming membership card or deck pass at coaches' check in and make them available throughout the meet at the request of officials.
- All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
- Prelims and Finals will be swum for the 11 & over events. Timed finals for 10&Under events. Finals will be swum as follows: 11&12 A final, 13-14 A final, Open A&B finals. Ten lanes will be swum in finals. Based on the size of the meet, a B final may be added to 13&14 and a C final to Open.
- Also, based on the size of the meet, the meet director and meet referee reserve the right to move 11/12 events to the middle session. A timeline will be published on the Wednesday or before the start of the meet.
- Warm up times may be modified based on the size of the meet.
- Swimmers attending the meet without a coach must communicate with the meet director before the start of the meet for warm up placement with the host team.
- The 10&U 500 free will be swum mixed gender, but scored by gender.



- Based on timelines, the 11-12 relays and 13-14 relays are timed finals and may be swum in prelims or in finals based on timelines. A timeline will be published on the Wednesday or before the start of the meet.
- Teams are limited to an A and B relay per relay event.

WARM UPS:

Southeastern Swimming Meet Safety Guidelines and Warm-up Procedures will be in effect at this meet.

ELIGIBILITY:

Meet is an open invitational. USA Swimming registered athletes only may participate. Entries will not be accepted without current registration numbers. Coaches and officials must present evidence of certification (Card/deckpass) as required by SES Swimming. A swimmer's age on the first day of the meet will determine the age for the entire meet. **On deck USA Swimming registrations are not permitted**.

DISABILITIES:

Swimmers with disabilities are welcome and must complete the Information Form for Disabled Swimmers and return it with entries. Coaches are asked to check-in before the meet with the Meet Director for any accommodations. (see attached Disabled Swimmer Form)

ENTRIES DEADLINE:

Meet Entries, release forms, and entry fees including surcharges must be received by the Entry Chair by 5:00 p.m. on November 18, 2019. The Open 400 IM, 500 Free, Open 1000 Free, Open 1650 Free, 11-12 200 IM and 500 Free, and 10&U 500 Free will be deck seeded. Based on the number of entries some or all 200s may be deck seeded with positive check in as well. All other events will be pre-seeded. *Note: Late entries will be accepted based on lane space availability, and is at the discretion of the meet director/meet referee.* Entries are to be submitted to: eaqmeets@gmail.com



MEET FEES:

\$ 6.00 per individual event. \$15.00 facility fee per athlete. \$10 late entry fee. LIMITS:

Swimmers are limited to 3 individual events per day, not to exceed 7 events for the meet. Note: Limit for Friday timed final events is one event per athlete. The Meet Director/Meet Referee reserves the right to combine heats and/or events (including combining genders) in order to facilitate the conduct of the meet. The Meet Director/Meet Referee reserves the right to limit any event in order to run the meet within the time allocated.

AWARDS:

Ribbons will be awarded to the top 8 athletes in each event in the 12&Under age group events, broken down by 11&12, and 10&Under categories.

MEET FORMAT:

Prelims and Finals will be swum for the 11& over events. Timed finals for 10&Under events. Finals will be swum as follows: 11&12 A final, 13-14 A final, Open A&B finals. Ten lanes will be swum in finals. Based on the size of the meet, a B final may be added to 13&14 and a C final to Open. Heats and finals will be swum in a 10 lane course.

TIME TRIALS:

The time trial events are at the discretion of the Meet Referee. Only a coach can request a time trial by requesting with the meet director or meet referee. Swimmers may time trial but may not exceed the 6 events per day USA Swimming limit. Fees for additional time trials at the conclusion of the meet shall be \$10.00 per individual event. Time trial swimmers will need to provide two timers.

2019 WAIVER, ACKNOWLEDGMENT AND LIABILITY RELEASE
