FACILITY:

The Ensworth School offers a 10-lane, 50-meter competition pool, with a 6.5 foot minimum depth, non-turbulent lane lines, a fully automatic electronic timing system, and a scoreboard with lane/time/place display. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.

RULES:

- Unless otherwise noted herein, this meet shall be conducted in accordance with current USA Swimming Rules and Regulations.
- Please note that use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.
- Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.
- Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.



- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present.
- In the interest of safety and accident prevention, coaches, officials and swimmers are asked to observe all posted pool rules and to conduct themselves in a safe manner. Only coaches, swimmers, officials, and volunteers are allowed on deck.
- Chairs are permitted on the balcony overlooking the pool, but must be placed against the back wall, **not against the railing**.
- Friday afternoon events will be swum as timed finals, fastest to slowest, alternating male and female heats, by event.
- Coaches must show either current USA Swimming membership card or deck pass at coaches' check in and make them available throughout the meet at the request of officials.
- All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
- Warm up times may be modified based on the size of the meet.
- Swimmers attending the meet without a coach must communicate with the meet director before the start of the meet for warm up placement with the host team.
- Distance events on Saturday and Sunday will be swum fastest to slowest, alternating male and female heats. There will be a five minute break before all distance events on Saturday and Sunday.
- Chase starts may be considered based on number of entries.

WARM UPS:

Southeastern Swimming Meet Safety Guidelines and Warm-up Procedures will be in effect at this meet.

ELIGIBILITY:

Meet is an open invitational. USA Swimming registered athletes only may participate. Entries will not be accepted without current registration numbers. Coaches and officials must present evidence of certification (Card/deckpass) as required by SES Swimming. A swimmer's age on the first day of the meet will determine the age for the entire meet. On deck USA Swimming registrations are not permitted.

DISABILITIES:

Swimmers with disabilities are welcome and must complete the Information Form for Disabled Swimmers and return it with entries. Coaches are asked to check-in before the meet with the Meet Director for any accommodations. (see attached Disabled Swimmer Form)

ENTRIES DEADLINE:

Meet Entries, release forms, and entry fees including surcharges must be received by the Entry Chair by 5:00 p.m. on May 5, 2020. The Open 400 IM, 400 Free, 800 Free and 1500 Free, and Open 400 Free will be deck seeded. Based on the number of



entries some or all 200s may be deck seeded with positive check in as well. All other events will be pre-seeded. *Note: Late entries will be accepted based on lane space availability.* Entries are to be submitted to: eaqmeets@gmail.com

MEET FEES:

\$ 7.00 per individual event, \$10 for late entries. \$15.00 facility fee per athlete. \$3.00 per athlete for Southeastern Swimming (SES) surcharge, \$5.00 per athlete out of SES surcharge. LIMITS:

Swimmers are limited to (1) event on Friday and (4) individual events per day on Saturday and Sunday. The Meet Director/Meet Referee reserve the right to combine heats and/or events (including mixing genders) in order to facilitate the conduct of the meet. The Meet Director/Meet Referee reserves the right to limit any event in order to run the meet within the time allocated.

AWARDS:

Ribbons will be awarded to the top 8 athletes, by gender, in each event in the 12 & Under age group events, broken down by 11&12, 9&10 and 8&Under.

MEET FORMAT:

This is Timed Finals meet. Friday evening's events and distance events will be deck seeded. All other events will be pre-seeded. All races will be swum in a 50 meter course.

HEAT SHEETS:

Only electronic heat sheets will be available. These will be available on the Ensworth Aquatics website in a printable format.

TIME TRIALS:

The time trial events will be swum at the conclusion of the meet upon a coach's request to the Meet Director. Swimmers may time trial but may not exceed the 6 events per day USA Swimming limit. Fees for additional time trials at the conclusion of the meet shall be \$10.00 per individual event. Time trial swimmers will need to provide two timers. Time trials are at the discretion of the meet referee.

2020 WAIVER, ACKNOWLEDGMENT AND LIABILITY RELEASE

I, the undersigned coach or team representative, verify that all of the **swimmers** and **coaches** listed on the enclosed entry form/team information are registered and entered into the meet in accordance and subject to USA Swimming Rules and Regulation:

- .1 All Clubs, including seasonal clubs, shall ensure that all athletes and coaches participating in USA Swimming sanctioned competition(S) are members of their LSC and USA Swimming.

And as

False Registration – A host LSC may impose a fine up to \$100.00 per event against a member coach or a member club submitting a meet entry which indicates a swimmer is registered with USA Swimming when that swimmer or the listed club is not **properly** registered.

All swimmers, coaches and officials involved with USA Swimming competition must be registered. Additionally, meet directors.
